Feedback from the Participants

• *Background of the Participants*

• Internet connection problems faced by the participants

Initially there was some connectivity issue; however as the session progresses the internet connection problem got resolved and maximum number of participant attended the sessions without any difficulties.

• Effectiveness of the online program

Many registered participants were able to attend the workshop till the end and there were lively interactions with the resource persons. Observing the participants feedback, the organisers understood that many participants were benefited and enlightened by the program.

• Clarification of queries by the participants during the program

With active interaction, the participants could clear up their doubts from the resource persons.

• *Perception about the Resource person*

The resource persons were all proficient in their subject area, resourceful. Presentations were precise with clarity in explaining the concepts.

• Views about the online mode of the Program

With the online mode – more participants can be accommodated, less stressful, flexibility or freedom to delegate time towards different projects.

• *Views about the duration of the program*

One and half hour per session was excellent. The participants and resource persons were not so much stressed out. Therefore the duration of program was appropriate. It can also be mentioned that a Workshop such as this needs at least two days to cover the various areas under the given theme. Therefore the Two days workshop was ideal duration.

• Views about attending similar program in future

The successful conduct of the workshop and positive responds indicates that participants will be looking forward for such program in future.

• Views about sharing of information about the program with others

The benefits of information learnt from attending such program, it willhave a ripple effect of sharing with others.

Conclusion and Recommendation

The workshop successfully addressed, the need for better awareness about IPR and helping equip young students to face a world which is increasingly focussed on innovations, research and creations.

Today, with the rising percentage of unemployment, it is crucial to train young population which constitute around 65% to make them innovative and self- reliant. Therefore, funding agency can provide funds to organised workshops/seminars on employability skill.
