In India youth in the age group of 15-29 years comprise 27.5% of the population. As seen from the demographic indicators of UN FPA Statistics, the countries having major numbers of youth population are exhibited as below:

2. If so, the strategies implemented to harness this potential for the development of the nation?

Considering the strength of youth community about 34% of India's Gross National Income (GNI) is contributed by the youth, aged 15-29 years. However, there exists a huge potential to increase the contribution of this class of the nation's citizenry by increasing their labour force participation and their productivity. The Government of India (GoI) currently¹ invests more than Rs 90,000 Crores per annum on youth development programmes or approximately Rs 2,710 per young individual per year, through youth-targeted (higher education, skill development, healthcare etc.) and non-targeted (food subsidies, employment etc.) programmes.

RGNIYD recognises the importance of program implementers as the cutting edge in the process of youth transformation. Hence, all its efforts are directed towards enhancing the knowledge and skills of the youth development functionaries.

Training programmes are multi-faceted in the field of,

1. Capacity Building
2. Skill Development
3. Life Skill Improvement
4. Mental Health Improvement
5. Training of Trainers
