#### **TERMS AND CONDITIONS:**

- 1) The posts are purely temporary and contract in nature.
- 2) Initial period of appointment will be for a period of 11 months. Depending upon the performance and the need to keep the post the contract may be extended for a further period on such terms and conditions as the administration of the Institute may decide.
- 3) The contract period / services may be terminated by the Institute without assigning any reason thereof.
- 4) The candidate may quit the services of the Institute after giving one month's notice in advance.
- 5) The Institute may terminate his/her services after giving one month's notice in advance. However the Institute reserves its right to terminate his/her services immediately if his/her services are not satisfactory or his/her conduct during the discharge of his/her duties is not appropriate to his/herstatus.
- 6) He/she is not entitled to any other benefit other than the remuneration.
- 7) Mere submission of application will not qualify the candidates for being called for interview. The Institute reserves the right to call for interview only those candidates, whom, the Institute may deem fit, will be suitable for the post.
