The quotations will be opened on the same day at 16.00 hours.
3. The successful bidder will be required to remove the material on the same day or next day after acceptance of the tender subject to making full payment by demand draft in favour of Director, RGNIYD, Sripurbudur.

4. The RGNIYD reserve the right to reject any or all quotations completely or partially without assigning any reason thereof. In this respect the decision of the RGNIYD will be final.
